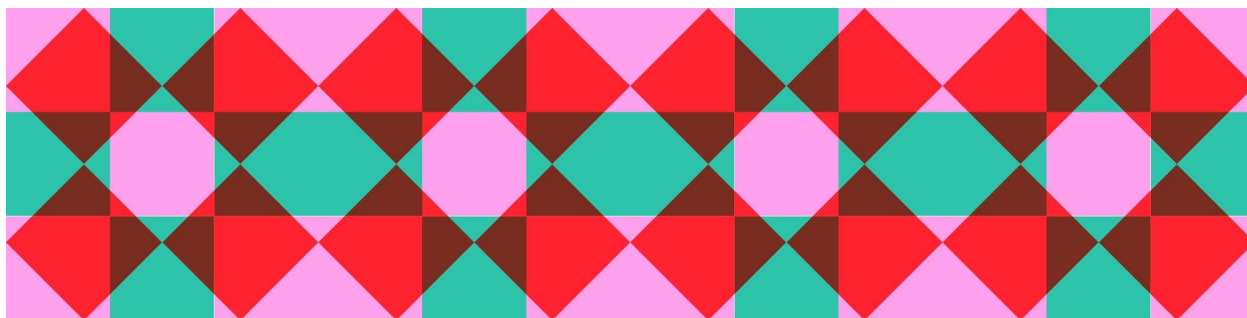

Participant / You - the individual purchasing and attending the Workshop(s).

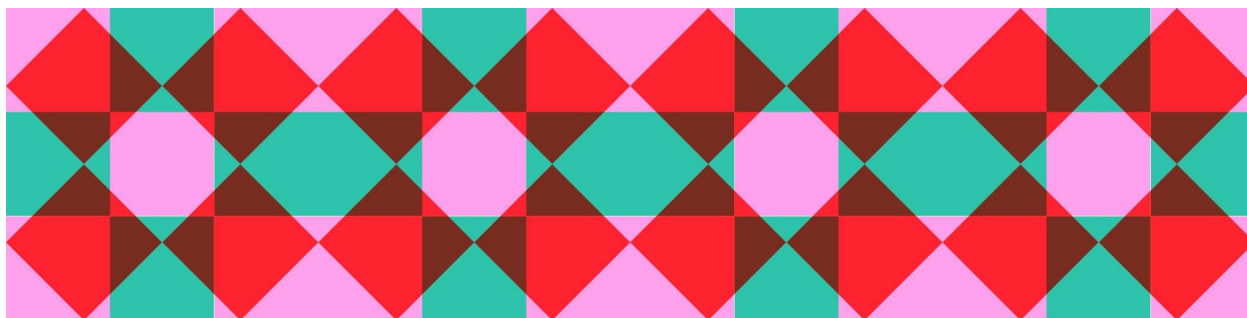
Workshop(s) - online educational sessions provided by CSC SRL.

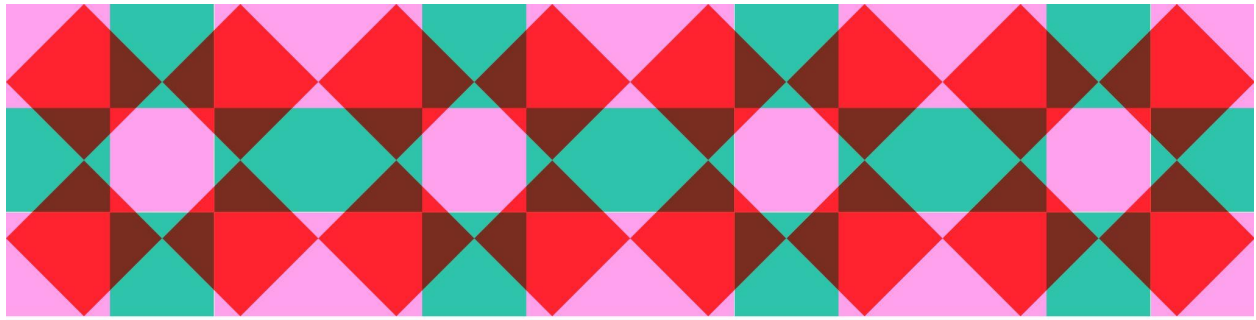
Booking and Payment

Intellectual Property

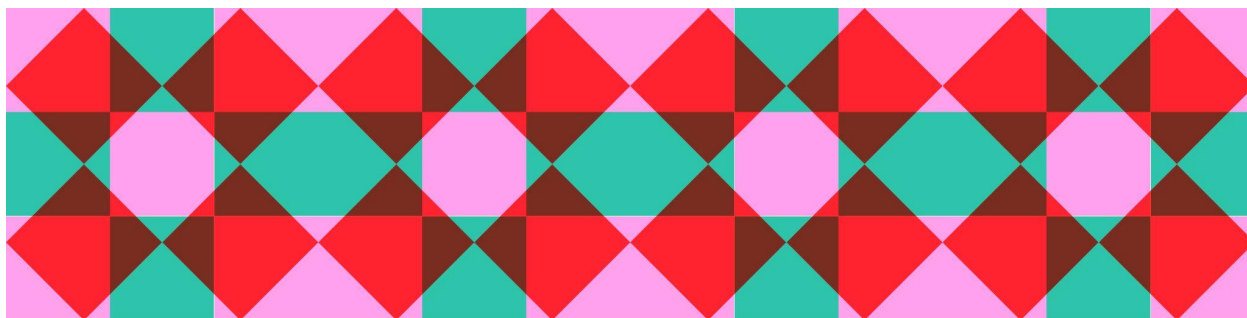
