



## TERMS & CONDITIONS

### THE ACADEMY

### INFORMATION WE COLLECT

The personal information we collect, store and use about you for the CSA consists primarily of information that you voluntarily provide to us by filling in the Academy Booking Form. This information is necessary for compliance with applicable laws and regulations and for personalising your experience as a CSA student. Sharing your mobile phone number with us is only necessary if you wish to be part of the Whatsapp CSA Academy 2022 Group and CSA Alumni Group.

In addition to this, personal information also extends to message content such as messages, image messages, voice messages, comments provided through e-mail communication, phone messaging, or platforms such as Slack, Whatsapp, Instagram and LinkedIn.

### FEES

Any fees and charges will be paid before the Academy starts. The fees are payable once you register for the Academy. We only accept online payments. Our Website works with integrated payment via Stripe. A service fee is retained by Stripe from the beneficiary account (i.e. from us - Cultural Sustainability Consulting SRL).

We also accept and prefer direct wire transfers for the Academy which avoids any 3rd party costs. ## **GOVERNING LAW AND JURISDICTION**

The Services, Courses and Academy are managed by Cultural Sustainability Consulting SRL, a legal entity located in Romania, tax identification number 44041886, legally represented by Monica Boța-Moisin (**CSC SRL**). The provision of services by CSC SRL is governed by Romanian Law and any dispute related to the provision of services and these Terms of Use will be governed by the laws of the State of Romania, excluding its conflicts of law provisions.

## **REFUND POLICY**

The Academy Material provided by CSC SRL consists of intangible goods - digital materials, online sessions, presentations and dynamic interactions with Academy Facilitators and Academy Participants (also referred to as a 'Digital Products').

In case you wish to cancel your registration for the Academy, you will need to do this within 5 calendar days from the date of enrolment on the basis of a motivated written cancellation submitted to [office@culturalintellectualproperty.com](mailto:office@culturalintellectualproperty.com). If you cancel your registration within 5 calendar days from the date of registration, you are eligible to receive 75% of the paid fees back.

Once your final registration for the Academy is confirmed, you will receive a 'Welcome Pack'. After receipt of the 'Welcome Pack' cancellation of enrolment in the Course will no longer be possible and no refund is applicable.

*Reference Note:* Cancellation is possible only until Friday 29th April 2022 for a maximum 75% refund of participation fees. After this date, no refund is possible.
